- 1 Oak Forest – Mrs. Dempsey informed the board of building work being completed with the Innovation grant funding. In sports, the students are competing and winning championships, and the Freshman leadership at Bridges was held.  
 Bremen HS – Dr. Rucinski thanked the Board for the Innovation grant funds. The students are pleased with the recent upgrades in the IMC and classrooms. An Honors Assembly breakfast was held for 225 students, one of Bremen’s students is an Evans Scholarship recipient, SAT prep has been completed, and they welcomed the class of 2027.
